## 1362ND INTERNATIONAL AGRICULTURAL FAIR – GENERAL REGULATIONS FOR PARTICIPATION

## 1) DEFINITIONS

The term 'Event' refers to the 1362nd International Agricultural Fair, organised at the Santa Lucia di Piave Trade Fair Centre from 10 to 12 December 2022. The term 'Regulations' refers to these general contractual conditions. The term 'Organiser' refers to the owner of the event organisation and its brand, i.e. Azienda Speciale S. Lucia Fiere, Piazza 28 Ottobre 1918, 1, 31025 SANTA LUCIA DI PIAVE, who draws up this

agreement as lessor of the exhibition areas and correlated services. The term 'Exhibitor' refers to those taking part in the Event as users of the exhibition areas with their own stand, staff and products, who shall sign this agreement directly with the Organiser (direct owner of the area or stand). The Direct Exhibitor is responsible for ensuring that the goods of any co-exhibitors and represented companies correspond to the commodity group stated.

## 2) EVENT VENUE

Santa Lucia di Piave Trade Fair Centre.

## 3) COMMODITY GROUP

The Organiser may accept only Exhibitors whose activities fall within the commodity group for which the Event is authorised, i.e. the following products and services: agriculture, oenology, agri-food, forestry, alternative energy, building, furniture, earth-moving equipment, publishing and services. Only new or fully overhauled machines and equipment shall be exhibited. The Organiser may admit – directly or through their representatives – all Italian and foreign producers, dealers, authorities, institutions and consortia operating in the commodity groups herein.

Representatives may take part in the Event exclusively in such capacity, under their own business name. At the Organiser's discretion, and by means of special written authorisation, used machinery and equipment may be exhibited if the Exhibitor's main activity is not the production/resale/representation of such machines and equipment. This is not applicable when the goods are for hire or exhibited in a specially dedicated area. The distribution of flyers/pamphlets is strictly forbidden.

## 4) EVENT DURATION AND OPENING HOURS

The Fair will be open to the public Saturday 10, Sunday 11, and Monday 12 December 2022.

## OPENING HOURS:

SATURDAY 9 a.m. / 6 p.m. (FILANDE 7 p.m.)  
SUNDAY 9 a.m. / 6 p.m. (FILANDE 7 p.m.)  
MONDAY 8 a.m. (FILANDE 9 p.m.) / 6 p.m.

The Pavilions will be open to Exhibitors from 8 a.m. to 7.30 p.m. (6.30 p.m. for Campo Fiera), and on Monday 12 December 2022 from 7.00 a.m. to 6.30 p.m.

Minors under 14 years of age are admitted only if accompanied by an adult.

FINES: Exhibitors shall be in attendance on their stands throughout the duration of the Event. Leaving the stand before the established closing time on the last day, 12 December 2022, will automatically cause the application of a fine of euro 500.00 + VAT if applicable.

## 5) SET-UP AND DISMANTLING TIMES

## 6) ADMISSION

Acceptance of applications from prospective participants is at the discretion of the Organiser, and the following may be admitted as exhibitors:

a) Italian or foreign companies exhibiting their own products or services falling within the commodity groups included in the Event. If the producers themselves do not take part in the Event, their dealers, agents or exclusive representatives;  
b) trade associations, public authorities and organisations that promote and study the sectors involved in the Event, and collect and disseminate information.

For reasons connected to the Event, the Organiser reserves the right to exceptionally admit companies, authorities or organisations lacking the above-mentioned requirements, to exclude certain services, products or samples or prohibit their presentation on a number of different stands pertaining to the same commodity group. **Applications to take part can be downloaded on the company's website [www.fieresantalucia.it](http://www.fieresantalucia.it), and must arrive in the Organiser's secretariat (email [info@fieresantalucia.it](mailto:info@fieresantalucia.it)) by 30 September 2022, signed by the company's owner or legal representative. Data must be entered into the special application form on the company's above-mentioned website. The form must be completed as required and cannot contain reserves, conditions or any additional clauses and must be received within the terms indicated by the Organiser at the Event Secretariat, Azienda Speciale S. Lucia Fiere, Piazza 28 Ottobre 1918 1, 31025 SANTA LUCIA DI PIAVE. Only fully completed application forms received from applicants who have paid the due amounts within the established time will be examined. The interest-free confirmation deposit must be paid when the application is forwarded. If the application form is received by 31 July 2022 there will be a discount on the registration fee.**

By signing the application form the Exhibitor firmly undertakes, subject to clause 7 herein, to take part in the Event on the conditions in these 'General Regulations for Participation', and at the same time undertakes to observe all the additional conditions in the 'Technical Regulations' and any other rules the Organiser sees fit to adopt to amend, integrate or waive the regulations. As the application form is to all intents and purposes a

## 7) STAND AREA ASSIGNMENT

Stand areas shall be assigned according to the general plan of the Event and the Organiser has the right to vary them in terms of sector, position and area at any time. The Exhibitor will not have any right to an indemnity or compensation for any reason, except for a reduced rental if a smaller area is occupied. Stand areas unoccupied when the Event opens shall be considered renounced and the Organiser may use them as it wishes without any obligation to refund. In any case, the entire amount for area occupation fees will be due.

## 8) SUBLETTING AND TRANSFER NOT ALLOWED

Assigned stands cannot be transferred. Subletting is not allowed and if it takes place all the parties involved shall be excluded from the Event.

## 9) PARTICIPATION FEES

By signing the application to take part, the Exhibitor declares that it knows and accepts the General Regulations and accepts their characteristics and the costs described below:

## 10) PAYMENT

## 11) CONFIRMATION – WITHDRAWAL – TERMINATION – NON FULFILMENT

contractual offer, it does not bind the Organiser, who has the right to integrate, amend and annul any previous provisions and waive them, advising in the way it deems suitable.

When the Organiser receives confirmation (which has the status of a contractual offer), it will decide who to admit or exclude, assessing all useful, relevant circumstances that will ensure a positive outcome of the Event and progressively enhance the qualification of the Exhibitors taking part. Equal access opportunities shall be guaranteed for all operators concerned. In particular, the decision regarding admittance or refusal shall be made observing the following illustrative circumstances: the exhibitor's habitual participation in events organised or hosted by the Santa Lucia di Piave Municipality, any pre-emption rights or application priority, the exhibitor's importance or prestige, any other facts that may be of objective importance for the selection (such as, for example, violation of the event regulations on previous occasions, previous or current insolvency, even when settled, behaviour that created such problems in previous participations as to suggest rejecting the application, etc.). Taking into account the above-mentioned, if suitably motivated written application is made within seven days of the communication of such decision a rejected applicant may require the Organiser to provide the reasons for such rejection and within 60 days of the end of the Event the Organiser shall provide the motivation for rejection of the application. In the event of exclusion, the applicant shall have the sole right to a refund of any monies deposited, without interest.

Any other directives or regulations that could amend the conditions of these general regulations, including those for health reasons linked to the pandemic, shall be immediately and automatically applicable, even when these points in the General Regulations have not been amended or changed. Furthermore, at any time the Organiser has the right to make the provisions it deems opportune regarding fire prevention, occupational hygiene, accident and damage prevention, and the safety of participants and visitors. Exhibitors may be informed of such provisions by any means available, and they shall prevail over the previously adopted General Regulations.

Any changes or exchanges must be authorised and made at the Exhibitor's expense. It is obligatory for the Exhibitor to strictly observe and apply directives designed to reduce the health risk arising from Covid-19, applying the protocols in force at the time of signing the agreement and any later amendments and integrations made by the State or Regional Authorities.

In the area named Campo Fiera main roads are Via Piave, Via Tagliamento and Via Livenza to a depth of 10 metres. The Area is divided into fixed modules with a minimum area of 50m<sup>2</sup> each.

OUTDOOR areas and SHEDS IN THE CAMPO FIERA AREA are not equipped in any way. INDOOR areas are provided with stands, panels and an electricity supply socket (1 kW).

instalment towards the balance: it is understood that participants renounce the right to attribute payments in the way described in Art. 1193, clause 1, Italian Civil Code. The Organiser shall provide the Exhibitor with a receipt for payment to attribute to full payment or an instalment towards payment of the outstanding debt, pursuant to Art. 1195 Italian Civil Code.

Removal of the products exhibited during the Event is subject to the issue of authorisation. Such authorization shall not be issued to Exhibitors who have not paid the rental for the area occupied and the services used. To guarantee any credit from the participating Exhibitor, the Organiser has the right to withhold goods and objects exhibited, as well as the material used for the stand. If payment is not made within two months of the end of the Event such material shall be auctioned off and the Organiser shall withhold the amount due to its credit. All the Organiser's credits of any kind are subject to the terms described in Art. 2764 Italian Civil Code.

communication of withdrawal/termination be received after such date, or if the stand area is not occupied by 12 noon on the day before the Fair opens, the participant shall pay the entire participation fee, as per Art. 6 above, and the confirmation deposit withheld as a fine for non-fulfilment.

Subject to the above, in the event of the applicant's withdrawal, termination or non-fulfilment the relative stand area will be at the free disposal of the Organiser.

Each Exhibitor shall be assigned two parking places outside the Trade Fair Centre in the parking lots established by Azienda Speciale Santa Lucia Fiere until space is available. The issue of a 'Car Park' badge does not attribute any responsibility to the Organiser for the parked vehicles, as the parking lots are not manned. The person parking the vehicle, or its owner, is responsible for any risks, including theft and damage, expressly exonerating the Organiser from any costs and liability.

### 13) INSURANCE - SECURITY

In its own interests and for its own needs, the Organiser provides an ordinary day and night security service which does not make it liable for any thefts or damage to goods exhibited on stands or in any way stored in the Trade Fair Centre.

Protection and surveillance of the stands are the responsibility of the participants throughout the pavilion opening hours, during the Fair itself and in the set-up and dismantling periods.

We therefore recommend that participants exhibiting goods that can be easily removed should be in attendance on their stand throughout the day.

### 14) STAND CLEANING

Cleaning of stands is at the expense of participants using their own personnel. Exhibitors must undertake to observe and punctually apply all current rules and regulations and later amendments and integrations regarding the health risk posed by Covid-19.

### 15) ADVERTISING, PUBLICATIONS, INDUSTRIAL PROPERTY RIGHTS

Each Exhibitor may advertise exclusively on its own stand, limited to its own production, as long as such activity does not disturb other participants or guests. In any case, audio advertising and anything else that could be in conflict with other exhibitors are prohibited. The Organiser reserves the right to allow paid-for advertising outside the assigned exhibition areas. With no liability for any omissions or errors, the Organiser arranges the printing of the list of Exhibitors and other informative documents it deems useful to promote the

### 16) PROHIBITIONS

It is strictly prohibited to:

- Exhibit products not included in any of the commodity groups or not indicated in the application to participate.
- Stay in the Trade Fair Centre outside Fair opening hours.
- Circulate with or park any kind of vehicle within the exhibition area.
- Set the exhibited machines in motion, unless authorised in writing by the Organiser.

### 17) TECHNICAL AND ORGANISATIONAL REGULATIONS

The Exhibitor acknowledges that the general arrangements and information, as well as the technical regulations and any later amendments communicated, are an integral part of the General Regulations. The Organiser reserves the right to issue further rules or regulations in order to organise the Event in the best way

### 18) POSTPONEMENT – REDUCTION OR CANCELLATION OF THE FAIR – FORCE MAJEURE

At its incontestable discretion, Azienda Speciale Fiere di Santa Lucia may change the dates of the Event. Up to thirty days prior to its opening the Organiser shall have the right to reduce or remove stand areas, advising the Exhibitors via certified email or any other suitable means, with no obligation to pay fines or damages. In the event of postponing the Fair to the next solar year, due to force majeure or in any case for causes outside the control of the Organiser, after receiving communication by certified email or any other suitable means,

### 19) GENERAL ARRANGEMENTS

The Exhibitor transfers to the Exhibitor the obligation to observe the instructions given by authorities providing security for places open to the public for the purpose of protecting guests and participants, including rules concerning the Covid-19 health emergency. Any complaints to the Organiser must be presented promptly in writing no later than the closing day of the Event. The Organiser reserves the exclusive right to photograph, film, sketch or otherwise reproduce the Event, overall, in detail or focussing on stands.

### 20) LEGAL DOMICILE AND COMPETENT COURT

The Participant elects domicile in the Organiser's registered office and recognises the exclusive jurisdiction of the Court of Treviso to all intents and purposes.

### 21) PRIVACY POLICY PURSUANT TO EU DIRECTIVE 2016/679

According to EU Regulation 2016/679 (GDPR) and Italian Legislative Decree 196/2003, (Personal Data Protection Code), Azienda Speciale Fiere di S. Lucia, hereafter 'the Company', is the Data Controller responsible for data processing, who can be contacted at the following addresses: Azienda Speciale S. Lucia Fiere – Piazza 28 Ottobre 1918, 1 - 31025 SANTA LUCIA DI PIAVE – email: direzione@fieresantalucia.it.

#### Scope of Processing

Personal data are processed within the scope of the Company's institutional activities, for the following purposes:

- strictly connected to and instrumental for managing relationships with clients and suppliers (e.g. collection of preliminary details when concluding a contract; carrying out operations and providing services required by obligations under the concluded contract, etc.) and for credit protection (assignment to debt collection agencies, factoring companies and/or banks);
- related to the development of the Company's activities, for which the Data Subject may withdraw its consent. This category includes:
  - sending clients information or advertising material concerning the trade fairs organised annually by the Company;
  - assessing clients' satisfaction, also through companies specialising in market surveys;
  - connected with obligations pursuant to laws, regulations, EU rules and instructions from legitimate authorities (e.g. tax regulations, statistics, etc.).

Failure to provide data will make it impossible to create a commercial relationship.

#### Categories of subjects to whom data can be communicated

Processing is carried out by the Company's personnel. The Company also performs its activities through:

- outsourced companies whose activities are strictly connected and instrumental to managing relationships between the Company and its clients. Data processing is performed by them for the following purposes:
